Jerry Clontz discussed re-seeding several areas at the Park. The quote received from Team Turf, Inc. was \$2,925 to aerate, seed and fertilize Park areas (around shelter/playground, tree area and flagpole circle.

John Biggers made a motion to approve the Park re-seeding project for \$2,925 with Team Turf, Inc. Patricia Kindley seconded the motion. Council members Biggers, Clontz, Kindley and Wilfong voted yes (4-0).
