# FAIRVIEW TOWN COUNCIL MEETING DECEMBER 21,2009 FAIRVIEW TOWN HALL Regular Meeting- Public Hearing 7:00 PM

The following members were present, constituting a quorum: Mayor ProTem Elizabeth Long, Bradley Purser, Bill Thomas and Jerry Clontz

The meeting was opened by the Mayor ProTem Elizabeth Long. Bradley Purser made a motion to amend the agenda of number 1 on section E to be moved to discussion. Bill Thomas seconded it. Thomas voted yes. Purser voted yes. Clontz voted yes.

The Oath of Office was done by Jerry Clontz and Bradley Purser as newly elected officials by Town Clerk, Jan Carter.

**Appointment of Mayor Pro-Tem**: Bill Thomas made a motion to have Elizabeth Long as Mayor Protem. Jerry Clontz seconded it. Thomas voted yes. Clontz voted yes. Purser voted yes.

**Resolution on Meeting Dates for 2010**: Mayor Protem Long discussed this. Bill Thomas made a motion to accept these dates. Jerry Clontz seconded it. Thomas voted yes. Clontz voted yes. Purser voted yes.

#### **Public Comments:**

April Purser talked to the Council about a donation for the Noel Williams ball field. She is with Piedmont Recreation Association. She gave out the reports.

#### **Financial and Tax Reports:**

Financial Reports were handed out by Christine Surratt. Bill Thomas made some comments about Darrell Baucom. Tana McConnaughey's tax collection report had been passed out.

Mayor ProTem Long stated that the Public Hearing is now open. Old business: Public Hearings

- **1. Request for Conditional Use Permit** #CUP-09-001 on Parcel #08186004A zoned RA-40. Daniel and Melissa Hines were sworn in by the Town Clerk Jan Carter. Land Use Administrator Ed Humphries discussed their request for this permit to operate as a nursery. They want a greenhouse operation. Melissa Hines presented pictures of the greenhouse to the Council and explained the water runoff. She showed them some pictures of future buildings that they want and parking lots. They don't want to sell equipment. Ed Humphries discussed the zoning. Bill Thomas asked a few questions.
- a. Decision on request: The Council talked about the Quasi-Judicial procedure.

It is a health and a safety area, it would not affect the value of the adjourning land, And the Condition Use is in harmony with the area and Conditional Use will be in conformity of the land use plan.

The Public Hearing was closed. And the regular meeting was opened. Bill Thomas made a motion that the public health or safety will not be in danger. Bradley Purser seconded it. Thomas voted yes. Clontz voted yes. Purser voted yes.

Jerry Clontz made a motion that this would not substantially injure the value of the adjourning or abutting land. Bradley Purser seconded. Purser voted yes. Clontz voted yes. Thomas voted yes.

#### **Conditions**

Bill Thomas made a motion to issue this permit with the 2 conditions. Jerry Clontz seconded it. Thomas voted yes. Clontz voted yes. Purser voted yes.

Mayor Protem Long opened the Public Hearing:

#### 2. Request to rezone Parcel #08222011F from RA40 to CUD-LI-09-01

Ed Humphries discussed this land that is owned by BB Haigler. Mr. Haigler explained that he sold the business. He wants the land to be light industrial. This is 4.86 acreas.

The public hearing was closed by the Mayor Protem Long.

a.Decision on request:

The regular meeting was opened.

Bill Thomas made a motion to change the zoning to the request by Mr. Haigler. Bradley Purser seconded it. Thomas voted yes. Purser voted yes. Clontz voted yes.

Bill Thomas says this is in line with the land use and is consistent with the recommendations for the Town's adopted comprehensive plan, the Town of Fairview Land Use Plan and the Land Use Ordinance.

Mayor Protem Long opened this 3<sup>rd</sup> Public Hearing:

### **3. Request to Amend Section 180N** of the LUO by adding "Requirement for Shopping Centers: Permit #TC-09-01

Ed Humphries discussed these shopping requirements and the ordinance of 50,000 square feet. The Planning Board is still discussing this.

a. Decision on request:

Bill Thomas made the motion to continue this as a Public Hearing next month, January 2010. Bradley Purser seconded it. Purser voted yes. Thomas voted yes. Clontz voted yes.

#### New Business:

#### 1. Consider adoption of a contract with Union County to collect taxes.
