Old Business

Special Event Definition: Humphries explained to the Board that the Council wanted to clarify the definition and requirements that would "trigger" obtaining a Temporary Use Permit in Fairview.

After discussion by the Board:

Nancy Randall made a motion to recommend the following definition of Special Event to the Town Council as a text amendment (page 47 in the Land Use Ordinance):

<u>Special Event</u> – Circuses, fairs, carnivals, festivals, rodeos or other types of activities that require a Temporary Use Permit if <u>any</u> of the following apply in connection to the event:

- Causes any disruption to traffic;
- Has vendors selling products or services for profit;
- Charge an admission fee either to enter the event or park at the event;
- Has amplified sound in any form;
- Advertises the event by signage, ads in the media, electronic media or any other means.

In addition to the definition, the Planning Board recommends adding to the text change: <u>not</u> to require a Public Hearing in connection with the Permit Approval process (section 161, Special Permits, page 141, 142).
