#### **Items of Business**

#### A. Text Amendment TC-16-049

Mr. Humphries stated that this amendment (Criteria for approving Uses to determine that the proposed use(s) has an impact that is similar in nature, function, and duration to the other uses allowed in a specific zoning district) is a result of Attorney Joe McCollum's attendance at the 2016 Municipal Attorney Conference in Asheville in August. Members discussed the amendment and made their recommendations.
