#### Item 3: Discuss/Adopt 2021-2022 Budget Ordinance for fiscal year

Darrell Baucom presented the 2021-2022 budget ordinance. The Council discussed.

Patricia Kindley made a motion to adopt the 2021-2022 Budget Ordinance. Gary Wilfong seconded the motion. Council members Clontz, Kindley and Wilfong voted yes (3-0).

#### Item 4: Discuss/Approve updating Solar Energy Ordinance, Section 180P

Ed Humphries presented an updated Solar Energy Facility Ordinance to replace the current Land Use Ordinance Section 180P. Mr. Humphries reported that this ordinance was taken from the state provided template. Mr. Humphries reported that the Planning Board recommends the ordinance to the Council by a unanimous vote.

Gary Wilfong made a motion to approve the Solar Energy Ordinance Section 180P as amended. Patricia Kindley seconded the motion. Council members Clontz, Kindley and Wilfong voted yes (3-0).

## Item 5: Request for funds from Turning Point, Inc.

Per Jessie Lindberg, Executive Director, Turning Point, Inc. presentation, they requested for funds in the amount of \$700.00. The Council discussed.

Gary Wilfong made a motion to approve \$500.00 for Turning Point, Inc. Patricia Kindley seconded the motion. Council members Clontz, Kindley and Wilfong voted yes (3-0).

#### Item 6: Septic System – Rental House

Mayor Thomas reported a problem with the septic system at the rental house. The work can be done this week, since the tenant is currently out of town. He is working on getting quotes now, but currently has no cost estimate.

Patricia Kindley made a motion to approve the repairs needed to the rental house septic system to be invoiced July 1<sup>st</sup>. Jerry Clontz seconded the motion. Council members Clontz, Kindley and Wilfong voted yes (3-0).

## **Council Comments**

Patricia Kindley thanked the Fairview Park Event Committee for a great job on the Music in the Park. The event was a great success.

Gary Wilfong also thanked the Fairview Park Event Committee for a great job on the Music in the Park. Mr. Wilfong stated that to provide a deputy for the town, taxes would have to be raised. Mr. Wilfong questioned what the cost would be for a permanent porta jon to have onsite at the park.

Jerry Clontz discussed the possibility of using the well at the rental house to water the grass at the wooded picnic area. A plumbing company will need to check out the well and pump. He will also be checking on grants for trails for the park.

Mayor Thomas reported that Darrell Baucom has completed and sent the paperwork necessary for the town to file for funds from the federal American Rescue Plan. Mayor Thomas and Mr. Humphries met with two representatives from U.S. Congressman Dan Bishop's office on today's date regarding needs of the town and what assistance Congressman Bishop's office may provide. Broadband and grants were discussed.

Jerry Clontz made a motion to adjourn. Patricia Kindley seconded the motion. Council members Clontz, Kindley and Wilfong voted yes (3-0).
