A. Building Arch at Park Entrance

The Committee discussed having a permanent archway entrance made similar to the one used at the Fall Festival. Various designs and materials will be investigated and priced.

B. Building Another Picnic Shelter

Jerry Clontz noted that he had received one estimate for the picnic shelter and was waiting on another estimate.

C. Park Anniversary Celebration

Mr. Clontz stated that the Committee will start planning the anniversary celebration in January.

D. Landscaping Around Flag Poles

The Committee discussed the landscaping they envisioned. B.B. Haigler made a motion to have Scott Cuthbertson take care of ordering/planting shrubs around light at the flag poles. Bill Riffle seconded the motion. Committee members Clontz, Cuthbertson, Haigler and Riffle voted yes (4-0).

E. Lighting at Picnic Shelter

Mr. Clontz reported that three outdoor florescent, two blub light fixtures have been ordered for the shelter.
