#### **Items of Business**

#### Item 1: Presentation by Benesch – Park Master Plan

Jon Wood, Senior Project Mgr., Benesch, presented the updated master plan for the park to the Council. Council discussed options and requested a cost proposal from Mr. Wood for preparing a Partif grant proposal and RTP proposal.

## Item 2: Re-appoint current members and appoint new members to the Planning Board

Ed Humphries presented the following Planning Board members for appointment or reappointment to the board:

Re-appoint: Greg Morgan, Josh Presley (regular members) and Fred Rogers (alternate member), terms to expire September 2025.

Appoint: Bill Thomas (currently an alternate) to fill the vacancy of Nancy Randall, term to expire July 2024.

Gary Wilfong made a motion to approve the persons submitted above to the Planning Board. Patricia Kindley seconded the motion. Council members Biggers, Clontz, Kindley and Wilfong voted yes (4-0).

#### **Item 3: Discuss Re-Roofing Town Hall**

Mayor Thomas opened a discussion about re-roofing town hall. As noted, when the property was purchased, the roof was at the end of its useful life. The Council discussed and decided to authorize obtaining roof specifications and bids for re-roofing.

John Biggers made a motion to authorize Tony Noviello, PRS Construction, to produce roof specifications for \$150 and obtain bids for the re-roofing. Jerry Clontz seconded the motion. Council members Biggers, Clontz, Kindley and Wilfong voted yes (4-0).

#### **Council Comments**

Jerry Clontz stated that he cleared a hornet's nest at the park.

Patricia Kindley stated that she and Gary Wilfong attended the open house at Fairview Elementary on August 25<sup>th</sup>.

Gary Wilfong thanked Patricia Kindley for the work she did to represent the Town of Fairview at the Fairview Elementary Open House.

Mayor Thomas reported that he had been asked and had added his name to a letter going to the State Board of Elections to request three additional early voting sites for Union County (Unionville Volunteer Fire Department, Euto Church, Union Elementary).	
John Biggers made a motion to adjourn. Jerry Clontz seconded the motion. Council members Biggers, Clontz, Kindley and Wilfong voted yes (4-0).
